# Summary Meeting Minutes August 13, 2022

Chairman, Ran Koch, convened the virtual meeting of the Neskowin Citizen Advisory Committee (NCAC) at approximately 10:02 am via a Zoom call. Officers present were Chair Ran Koch, Treasurer Chris Silkowski and Secretary Dave Benneth.

### **Introduction of Participants**

#### **Conflicts of Interest**

#### Approval of Minutes of June 11, 2022 NCAC Meeting

### **Treasurer's Report**

Chris reported there were no receipts or expenditures since the last meeting leaving the checking account balance unchanged at \$725. No payables were reported. In addition, he reported that the Neskowin Community Association approved a \$1,000 grant request to help fund the NCAC's website and Zoom subscription costs and that the funds would be received in September

#### **Short Term Rental Committee**

Hillary Gibson and Tom Prehoditch reported that the STR Subcommittee will take public comments regarding proposed limits on STRs at its next meeting at 6:00 pm on August 13 via Zoom.

### **Community Plan Update**

Chris reported that the Committee has completed a draft of its survey questions for the community plan, which are currently being reviewed by various subject matter experts. The next step will be developing and formatting the survey that will be used for soliciting citizen input on any changes that should be made to Neskowin's community plan in compliance with the State's 19 land use goals.

#### **Highway 101 Safety Proposals**

Ran reported that the Neskowin Community Association President is working on a request that Transient Lodging Tax funds be used to help install a crosswalk and/or a blinking sign on Highway 101 to enhance safety for pedestrians crossing the highway to the Saturday Farmers' Market.
