After the meeting on Thursday a new draft Vision and Values statement was created based on the comments that have been submitted. This is a DRAFT work in process to see if it makes more sense than the document we were working on Thursday.

The new document relates to the statements in the May 2nd discussion, and prior comments. The May 4th document is numbered 1 to 4 with letters indicating sub sections. The document from May 2nd is annotated with numbers that correspond to the new statements in the May 4th document

We will go through the new document section by section.
